Water Utility Rate Increase-takes effect with this month's readings. Not good news, but necessary. The village was able to do an 8% "simplified rate increase". I've been advised if the Public Service Commission (PSC) stepped in, it might've been higher, so hoping that this smaller increase takes care of some of the financial issues and that the village can maintain these rates into the future. Simple things like allowing emailing of your bill saves times and money on this end for supplies, postage, and time. I appreciate that I did not have any furious customers complaining about the increase...sadly, we are used to the price of everything going up.



SNOW-Say it isn't so-just a reminder that Ordinance #247 prohibits parking on any public street November 1 to April 1 between the hours of midnight and 7:00 am to allow for removal of snow. Please cooperate by keeping your vehicles off of the street between these hours. Everybody wants the streets to be clear early in the morning and the DPW employees start clearing very early in the morning even before we are awake so that the streets can be clear for you to get to work, appointments, or school! So far, the snow totals have been next to nothing, which is saving on expenses for snow removal this year. Mother Nature might have a surprise up her sleeve though, so be aware!
